Daily Market Update

Market closed in Red

The market closed in red today. The benchmark index DSEX (-0.02%) lost 1.12 points and closed at 5,314.33. The blue-chip index DS30 (+0.29%), the Shariah-based index DSES (+0.29%), and the large-cap index CDSET (+0.00%) closed at 2,057.16, 1,155.82, and 1,093.55 points, respectively. Most of the large-cap sectors posted positive performance today. Food & Allied booked the highest gain of 0.64% followed by Pharmaceutical (+0.54%), Fuel & Power (+0.21%), Telecommunication (+0.11%), NBFI (+0.06%), Engineering (+0.00%), and Bank (-0.84%), respectively. Block trades contributed 1.4% of the overall market turnover. Orion Infusion Ltd. (+8.5%) was the most traded share with a turnover of BDT 546 million.




