Daily Market Update

The market closed in red today. The benchmark index DSEX (-0.48%) lost 25.16 points and closed at 5,196.41. The blue-chip index DS30 (-0.16%), the Shariah-based index DSES (-0.45%), and the large-cap index CDSET (-0.32%) closed at 1,935.18, 1,162.16, and 1,066.96 points, respectively. Most of the largecap sectors posted negative performance today. Fuel & Power experienced the highest loss of 1.03% followed by NBFI (-0.67%), Pharmaceutical (-0.57%), Engineering (-0.38%), Bank (- $\frac{1}{6}$ 0.38%), Telecommunication (+0.04%), and Food & Allied (+0.19%), respectively. Block trades contributed 1.6% of the overall market turnover. Orion Infusion Ltd. (+0.3%) was the most traded share with a turnover of BDT 251 million.




