Daily Market Update

The market closed in red today. The benchmark index DSEX (-0.03%) lost 1.47 points and closed at 5,169.32. The blue-chip index DS30 (+0.05%), the Shariah-based index DSES (+0.24%), and the large-cap index CDSET (-0.23%) closed at 1,923.02, 1,158.69, and 1,057.56 points, respectively. Most of the large-cap sectors posted negative performance today. NBFI experienced the highest loss of 0.92% followed by Fuel & Power (-0.87%), Food & Allied (-0.19%), Telecommunication (-0.18%), Engineering (-0.06%), Pharmaceutical (+0.13%), and Bank (+0.51%), respectively. Block trades contributed 9.6% of the overall market turnover. Orion Infusion Ltd. (+3.4%) was the most traded share with a turnover of BDT 187 million.




