Daily Market Update

The market closed in green today. The benchmark index DSEX (+0.29%) gained 15.12 points and closed at 5,184.45. The bluechip index DS30 (+0.22%), the Shariah-based index DSES (+0.69%), and the large-cap index CDSET (+0.37%) closed at 1,927.28, 1,166.64, and 1,061.44 points, respectively. Most of the large-cap sectors posted positive performance today. NBFI booked the highest gain of 1.67% followed by Food & Allied (+0.86%), Engineering (+0.46%), Fuel & Power (+0.41%), Pharmaceutical (+0.23%), Telecommunication (-0.06%), and Bank (-0.26%), respectively. Block trades contributed 11.6% of the overall market turnover. Orion Infusion Ltd. (+0.3%) was the most traded share with a turnover of BDT 180 million.





Figure: Sectorial Turnover (BDT Mn)
