Market closed in Green

Daily Market Update

The market closed in green today. The benchmark index DSEX (+0.20%) gained 10.57 points and closed at 5,234.95. The bluechip index DS30 (+0.28%), the Shariah-based index DSES (+0.26%), and the large-cap index CDSET (+0.09%) closed at 1,926.50, 1,169.10, and 1,055.67 points, respectively. Large-cap sectors posted mixed performance today. NBFI booked the highest gain of 1.61%, followed by Pharmaceutical (+0.13%), Engineering (+0.04%), Bank (+0.04%), Food & Allied (-0.09%), Fuel & Power (-0.16%), and Telecommunication (-0.29%), respectively. Block trades contributed 2.9% of the overall market turnover. Orion Infusion Ltd. (-2.2%) was the most traded share with a turnover of BDT 167 million.




