Daily Market Update

The market closed in red today. The benchmark index DSEX (-0.27%) lost 14.1 points and closed at 5,253.79. The blue-chip index DS30 (-0.22%), the Shariah-based index DSES (-0.20%), and the large-cap index CDSET (-0.26%) closed at 1,926.19, 1,173.71, and 1,058.35 points, respectively. Most of the largecap sectors posted negative performance today. NBFI experienced the highest loss of 1.74% followed by Bank (-1.23%), Engineering (-0.19%), Telecommunication (-0.17%), Pharmaceutical (-0.05%), Food & Allied (+0.03%), and Fuel & Power (+0.23%), respectively. Block trades contributed 2.6% of the overall market turnover. IFIC Bank Ltd. (+5.5%) was the most traded share with a turnover of BDT 145 million.




