


Daily Market Update

The market closed in green today. The benchmark index DSEX (+0.03%) gained 1.72 points and closed at 5,218.16. The bluechip index DS30 (+0.11%), the Shariah-based index DSES (-0.33%), and the large-cap index CDSET (+0.19%) closed at 1,941.94, 1,165.07, and 1,068.15 points, respectively. Most of the large-cap sectors posted positive performance today. Telecommunication booked the highest gain of 1.38% followed by Bank (+1.16%), NBFI (+0.61%), Fuel & Power (+0.16%), Engineering (+0.16%), Food & Allied (-0.03%), and Pharmaceutical (-0.41%), respectively. Block trades contributed 4.0% of the overall market turnover. Orion Infusion Ltd. (-8.7%) was the most traded share with a turnover of BDT 271 million.


