


## **Daily Market Update**


The market closed in red today. The benchmark index DSEX (-0.02%) lost 1.01 points and closed at 5,150.87. The blue-chip index DS30 (-0.09%), the Shariah-based index DSES (+0.12%), and the large-cap index CDSET (-0.25%) closed at 1,904.42, 1,158.35, and 1,051.21 points, respectively. Most of the large-cap sectors posted negative performance today. Telecommunication experienced the highest loss of 1.54% followed by NBFI (-0.45%), Bank (-0.26%), Fuel & Power (-0.10%), Pharmaceutical (-0.02%), Food & Allied (+0.47%), and Engineering (+3.18%), respectively. Block trades contributed 2.2% of the overall market turnover. Khan Brothers PP Woven Bag Industries Limited (+0.1%) was the most traded share with a turnover of BDT 119 million.
