Daily Market Update

The market closed in green today. The benchmark index DSEX (+0.22%) gained 11.15 points and closed at 5,145.08. The bluechip index DS30 (+0.45%), the Shariah-based index DSES (+0.43%), and the large-cap index CDSET (+0.13%) closed at 1,902.89, 1,155.53, and 1,049.34 points, respectively. Large-cap sectors posted mixed performance today. Telecommunication booked the highest gain of 0.45%, followed by Pharmaceutical (+0.43%), Engineering (+0.21%), Food & Allied (-0.08%), Bank (-0.39%), Fuel & Power (-0.53%), and NBFI (-0.97%), respectively. Block trades contributed 6.1% of the overall market turnover. ADN Telecom Limited (+10.0%) was the most traded share with a turnover of BDT 146 million.




