Market closed in Green

Daily Market Update

The market closed in green today. The benchmark index DSEX (+0.32%) gained 16.76 points and closed at 5,216.07. The bluechip index DS30 (+0.26%), the Shariah-based index DSES (+0.23%), and the large-cap index CDSET (+0.29%) closed at 1,899.62, 1,166.61, and 1,046.85 points, respectively. Most of the large-cap sectors posted positive performance today. Food & Allied booked the highest gain of 0.81% followed by Bank (+0.44%), Pharmaceutical (+0.16%), NBFI (+0.10%), Engineering (+0.05%), Telecommunication (-0.12%), and Fuel & Power (-0.20%), respectively. Block trades contributed 4.0% of the overall market turnover. Taufika Foods and LOVELLO Ice-cream PLC (+1.6%) was the most traded share with a turnover of BDT 290 million.




