


Daily Market Update

The market closed in red today. The benchmark index DSEX (-0.11%) lost 5.66 points and closed at 5,201.70. The blue-chip index DS30 (+0.34%), the Shariah-based index DSES (-0.02%), and the large-cap index CDSET (+0.00%) closed at 1,887.88, 1,158.02, and 1,042.01 points, respectively. Largecap sectors posted mixed performance today. NBFI booked the highest gain of 2.80%, followed by Fuel & Power (+0.41%), Engineering (+0.38%), Pharmaceutical (+0.27%), Food & Allied (-0.09%), Telecommunication (-0.19%), and Bank (-0.75%), respectively. Block trades contributed 3.5% of the overall market turnover. Shinepukur Ceramics Limited (+2.0%) was the most traded share with a turnover of BDT 204 million.




