


Daily Market Update

The market closed in green today. The benchmark index DSEX (+0.39%) gained 19.28 points and closed at 4,921.56. The bluechip index DS30 (-0.27%), the Shariah-based index DSES (+0.15%), and the large-cap index CDSET (+0.01%) closed at 1,815.51, 1,075.90, and 1,006.18 points, respectively. Most of the large-cap sectors posted negative performance today. Food & Allied experienced the highest loss of 0.34% followed by Pharmaceutical (-0.30%), NBFI (-0.28%), Engineering (-0.27%), Telecommunication (-0.06%), Fuel & Power (+0.13%), and Bank (+1.33%), respectively. Block trades contributed 1.9% of the overall market turnover. NRB Bank Limited (-2.0%) was the most traded share with a turnover of BDT 189 million.


