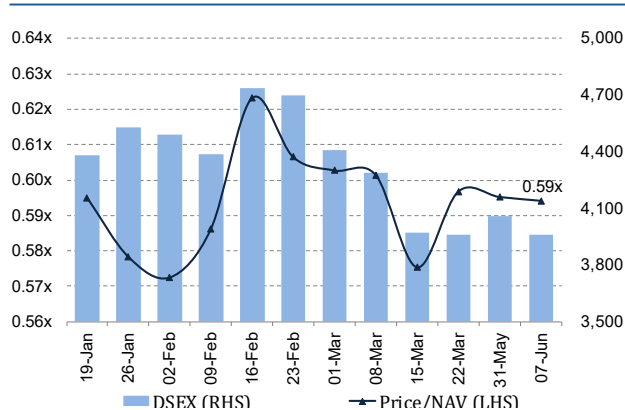




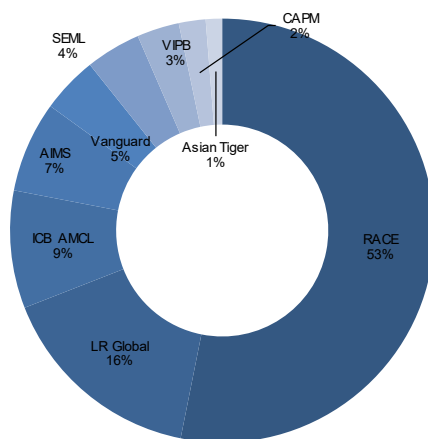
Weekly Report on Mutual Funds June 07, 2020

Chart 1 - Change in weighted average Price to NAV ratio of the sector in the last two months:



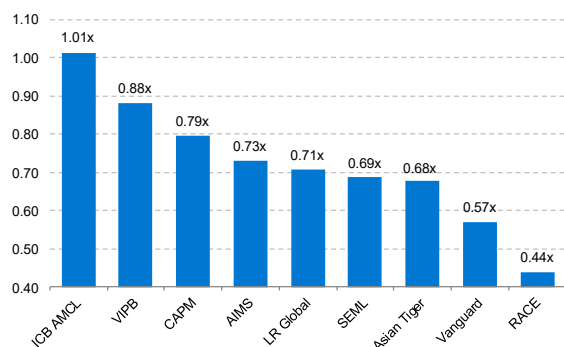

The fund managers have reported NAV of the closed-ended mutual funds for the week ending on June 04, 2020. Based on the recently reported NAV and today's (June 07, 2020) close prices, the sectoral Price to NAV stood at 0.59x, lower than last week's Price to NAV of 0.60x. On average, price of the mutual funds decreased by 0.50% and NAV of mutual funds decreased by 0.33% from previous week against a negative 1.37% WoW change in DSEX. Among all the asset managers, Asian Tiger performed best in terms of NAV return of its funds, gaining 1.26% during the week.

Among the 37 mutual funds, 32 of them were trading at discount. Market capitalization of 37 funds stood at BDT 29.5 billion (USD 360.1 million), while the Asset Under Management (AUM) of the sector stood at BDT 49.7 billion (USD 606.1 million). RACE holds the highest market share of 53.1% with 10 funds and AUM of BDT 26.4 billion. The fund manager has the lowest Price/NAV ratio of 0.44x, while Vanguard stood at the second lowest Price/NAV ratio of 0.57x. The average daily turnover of the sector stood at BDT 15.7 million in the last trading week, which was 22.1% lower than the previous week's turnover value.

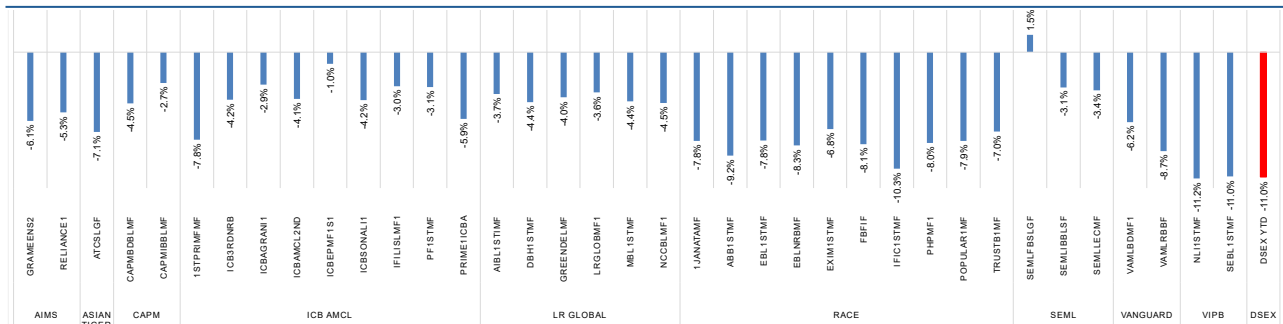
