


Daily Market Update

The market closed in red today. The benchmark index DSEX (-0.08%) lost 4.1 points and closed at 5,022.47. The blue-chip index DS30 (+0.41%), the Shariah-based index DSES (-0.06%), and the large-cap index CDSET (+0.28%) closed at 1,867.52, 1,121.20, and 1,029.13 points, respectively. Largecap sectors posted mixed performance today. Fuel & Power booked the highest gain of 1.03%, followed by Telecommunication (+0.45%), NBFI (+0.42%), Food & Allied (+0.23%), Pharmaceutical (-0.05%), Bank (-0.27%), and Engineering (-0.57%), respectively. Block trades contributed 3.7% of the overall market turnover. Shahjibazar Power Co. Ltd. (+10.0%) was the most traded share with a turnover of BDT 128 million.


