Daily Market Update

The market closed in red today. The benchmark index DSEX (-1.96%) lost 104.67 points and closed at 5,229.27. The bluechip index DS30 (-2.20%), the Shariah-based index DSES (-1.85%), and the large-cap index CDSET (-1.62%) closed at 1,859.03, 1,143.85, and 1,008.95 points, respectively. All the large-cap sectors posted negative performance today. Telecommunication experienced the highest loss of 2.97% followed by NBFI (-2.72%), Engineering (-2.67%), Fuel & Power (-2.27%), Food & Allied (-2.12%), Bank (-1.92%), and Pharmaceutical (-1.90%), respectively. Block trades contributed 29.8% of the overall market turnover. Unilever Consumer Care Limited (+2.0%) was the most traded share with a turnover of BDT 486 million.





Figure: Sectorial Turnover (BDT Mn)
