

Daily Market Update

The market closed in red today. The benchmark index DSEX (-2.12%) lost 125.2 points and closed at 5,778.64. The blue-chip index DS30 (-2.42%), the Shariah-based index DSES (-1.94%), and the large-cap index CDSET (-2.13%) closed at 2,126.61, 1,240.19, and 1,137.77 points, respectively. All the large-cap sectors posted negative performance today. Telecommunication experienced the highest loss of 2.99% followed by NBFI (-2.64%), Fuel & Power (-2.38%), Engineering (-2.36%), Bank (-2.31%), Food & Allied (-2.28%), and Pharmaceutical (-2.02%), respectively. Block trades contributed 4.1% of the overall market turnover. Grameenphone Ltd. (-3.0%) was the most traded share with a turnover of BDT 493 million.




