# **Daily Market Update**

The market closed in green today. The benchmark index DSEX

(+0.24%) gained 12.32 points and closed at 5,238.37. The bluechip index DS30 (+0.35%), the Shariah-based index DSES (-0.20%), and the large-cap index CDSET (+0.67%) closed at 1,927.88, 1,172.25, and 1,065.57 points, respectively. Largecap sectors posted mixed performance today. Pharmaceutical booked the highest gain of 0.84%, followed by Food & Allied (+0.50%), Bank (+0.32%), Engineering (-0.55%), Fuel & Power (-0.57%), Telecommunication (-0.73%), and NBFI (-2.03%), respectively. Block trades contributed 7.5% of the overall market turnover. NRB Bank Limited (-2.2%) was the most traded share with a turnover of BDT 143 million.






