# **Daily Market Update**

The market closed in red today. The benchmark index DSEX (-0.82%) lost 42.33 points and closed at 5,124.50. The blue-chip index DS30 (-0.75%), the Shariah-based index DSES (-1.08%), and the large-cap index CDSET (-0.59%) closed at 1,889.42, 1,142.10, and 1,047.42 points, respectively. All the large-cap sectors posted negative performance today. NBFI experienced the highest loss of 2.26% followed by Bank (-1.26%), Fuel & Power (-1.13%), Telecommunication (-0.92%), Food & Allied (-0.63%), Engineering (-0.58%), and Pharmaceutical (-0.45%), respectively. Block trades contributed 2.4% of the overall market turnover. Asiatic Laboratories Limited (+4.3%) was the most traded share with a turnover of BDT 117 million.




