Market closed in green

Daily Market Update

The market closed in green today. The benchmark index DSEX (+1.44%) gained 73.44 points and closed at 5,178.87. The bluechip index DS30 (+1.40%), the Shariah-based index DSES (+1.09%), and the large-cap index CDSET (+1.79%) closed at 1,908.32, 1,152.45, and 1,061.10 points, respectively. Most of the large-cap sectors posted positive performance today. Pharmaceutical booked the highest gain of 2.67% followed by NBFI (+1.15%), Food & Allied (+1.13%), Fuel & Power (+1.06%), Bank (+0.87%), Engineering (+0.44%), and Telecommunication (+0.31%), respectively. Block trades contributed 5.4% of the overall market turnover. Square Pharmaceuticals Ltd. (+4.9%) was the most traded share with a turnover of BDT 349 million.




