Market closed in green

Daily Market Update

The market closed in green today. The benchmark index DSEX (+0.88%) gained 45.72 points and closed at 5,224.58. The bluechip index DS30 (+1.11%), the Shariah-based index DSES (+1.24%), and the large-cap index CDSET (+0.69%) closed at 1,929.50, 1,166.74, and 1,068.39 points, respectively. All the large-cap sectors posted positive performance today. Telecommunication booked the highest gain of 1.69% followed by Bank (+1.13%), Engineering (+0.89%), Pharmaceutical (+0.78%), NBFI (+0.16%), Food & Allied (+0.10%), and Fuel & Power (+0.07%), respectively. Block trades contributed 5.2% of the overall market turnover. Orion Infusion Ltd. (+8.7%) was the most traded share with a turnover of BDT 352 million.




