


Daily Market Update

The market closed in green today. The benchmark index DSEX (+0.18%) gained 9.11 points and closed at 5,179.18. The bluechip index DS30 (-0.07%), the Shariah-based index DSES (+0.05%), and the large-cap index CDSET (-0.11%) closed at 1,912.90, 1,147.80, and 1,048.61 points, respectively. Largecap sectors posted mixed performance today. NBFI booked the highest gain of 2.16%, followed by Fuel & Power (+1.20%), Telecommunication (+0.38%), Bank (-0.07%), Engineering (-0.09%), Pharmaceutical (-0.23%), and Food & Allied (-0.71%), respectively. Block trades contributed 4.2% of the overall market turnover. Eastern Housing Limited (+9.9%) was the most traded share with a turnover of BDT 133 million.


