The market closed in red today. The benchmark index DSEX (-0.05%) lost 2.43 points and closed at 5,189.62. The blue-chip index DS30 (-0.04%), the Shariah-based index DSES (-0.03%), and the large-cap index CDSET (+0.04%) closed at 1,913.38, 1,152.35, and 1,050.34 points, respectively. Large-cap sectors posted mixed performance today. Pharmaceutical booked the highest gain of 0.24%, followed by Telecommunication (+0.20%), Food & Allied (+0.02%), Bank (-0.05%), Fuel & Power (-0.44%), Engineering (-0.55%), and NBFI (-0.63%), respectively. Block trades contributed 1.4% of the overall market turnover. Taufika Foods and LOVELLO Ice-cream PLC

(+2.0%) was the most traded share with a turnover of BDT 165




