# **Daily Market Update**

The market closed in green today. The benchmark index DSEX (+0.23%) gained 11.86 points and closed at 5,201.48. The bluechip index DS30 (+0.30%), the Shariah-based index DSES (+0.29%), and the large-cap index CDSET (+0.21%) closed at 1,919.11, 1,155.73, and 1,052.56 points, respectively. Most of the large-cap sectors posted positive performance today. Telecommunication booked the highest gain of 0.91% followed by Pharmaceutical (+0.50%), Bank (+0.31%), Food & Allied (+0.30%), NBFI (+0.14%), Engineering (+0.04%), and Fuel & Power (-0.34%), respectively. Block trades contributed 4.5% of the overall market turnover. Robi Axiata PLC (+2.1%) was the most traded share with a turnover of BDT 233 million.




