Daily Market Update

The market closed in red today. The benchmark index DSEX (-0.16%) lost 8.33 points and closed at 5,203.20. The blue-chip index DS30 (-0.31%), the Shariah-based index DSES (-0.04%), and the large-cap index CDSET (-0.13%) closed at 1,922.43, 1,160.23, and 1,054.30 points, respectively. Most of the large-cap sectors posted negative performance today. Telecommunication experienced the highest loss of 0.50% followed by Fuel & Power (-0.50%), NBFI (-0.37%), Pharmaceutical (-0.22%), Bank (-0.21%), Engineering (-0.04%), and Food & Allied (+0.13%), respectively. Block trades contributed 5.9% of the overall market turnover. Robi Axiata PLC (-0.3%) was the most traded share with a turnover of BDT 324 million.






Figure: Sectorial Turnover (BDT Mn)
