

Daily Market Update

The market closed in red today. The benchmark index DSEX (-0.07%) lost 3.64 points and closed at 5,126.42. The blue-chip index DS30 (+0.11%), the Shariah-based index DSES (-0.41%), and the large-cap index CDSET (-0.08%) closed at 1,896.97, 1,145.48, and 1,043.80 points, respectively. Most of the large-cap sectors posted negative performance today. Engineering experienced the highest loss of 0.88% followed by Bank (-0.24%), Fuel & Power (-0.17%), NBFI (-0.13%), Pharmaceutical (-0.06%), Food & Allied (+0.08%), and Telecommunication (+0.26%), respectively. Block trades contributed 1.4% of the overall market turnover. BRAC Bank Ltd. (+1.2%) was the most traded share with a turnover of BDT 138 million.






Figure: Sectorial Turnover (BDT Mn)
