Market closed in red

The market closed in green today. The benchmark index DSEX (+0.01%) gained 0.38 points and closed at 5,112.90. The bluechip index DS30 (+0.40%), the Shariah-based index DSES (-0.31%), and the large-cap index CDSET (+0.15%) closed at 1,903.85, 1,133.98, and 1,045.99 points, respectively. Large-cap sectors posted mixed performance today. Telecommunication booked the highest gain of 0.93%, followed by Bank (+0.92%), Fuel & Power (+0.60%), Food & Allied (+0.29%), Pharmaceutical (-0.51%), Engineering (-0.70%), and NBFI (-1.34%), respectively. Block trades contributed 5.0% of the overall market turnover. Agni Systems Ltd. (+1.1%) was the most traded share with a turnover of BDT 203 million.




