

## **Daily Market Update**

The market closed in red today. The benchmark index DSEX (-0.35%) lost 18.3 points and closed at 5,233.67. The blue-chip index DS30 (-0.42%), the Shariah-based index DSES (-0.56%), and the large-cap index CDSET (-0.37%) closed at 1,867.05, 1,137.26, and 1,005.00 points, respectively. Most of the large-cap sectors posted negative performance today. Pharmaceutical experienced the highest loss of 0.64% followed by NBFI (-0.64%), Fuel & Power (-0.52%), Engineering (-0.38%), Bank (-0.24%), Food & Allied (-0.24%), and Telecommunication (+0.32%), respectively. Block trades contributed 7.8% of the overall market turnover. Beach Hatchery Ltd. (+4.7%) was the most traded share with a turnover of BDT 139 million.


