Market closed in green

Daily Market Update

The market closed in green today. The benchmark index DSEX (+1.36%) gained 76.42 points and closed at 5,692.06. The blue-chip index DS30 (+1.27%), the Shariah-based index DSES (+1.51%), and the large-cap index CDSET (+1.13%) closed at 2,033.45, 1,250.98, and 1,075.16 points, respectively. All the large-cap sectors posted positive performance today. Food & Allied booked the highest gain of 2.23% followed by Pharmaceutical (+1.99%), NBFI (+1.30%), Telecommunication (+0.82%), Fuel & Power (+0.76%), Bank (+0.42%), and Engineering (+0.14%), respectively. Block trades contributed 4.5% of the overall market turnover. Orion Infusion Ltd. (+6.3%) was the most traded share with a turnover of BDT 411 million.




