

# **Daily Market Update**

The market closed in red today. The benchmark index DSEX (-0.03%) lost 1.74 points and closed at 5,725.28. The blue-chip index DS30 (-0.31%), the Shariah-based index DSES (-0.51%), and the large-cap index CDSET (+0.03%) closed at 2,040.38, 1,255.02, and 1,078.38 points, respectively. Large-cap sectors posted mixed performance today. NBFI booked the highest gain of 3.21%, followed by Bank (+1.41%), Engineering (+0.27%), Telecommunication (-0.23%), Fuel & Power (-0.27%), Pharmaceutical (-0.80%), and Food & Allied (-1.01%), respectively. Block trades contributed 9.2% of the overall market turnover. Best Holdings Limited (+8.5%) was the most traded share with a turnover of BDT 558 million.




