Daily Market Update

The market closed in red today. The benchmark index DSEX (-0.53%) lost 29.96 points and closed at 5,666.76. The blue-chip index DS30 (-0.43%), the Shariah-based index DSES (-0.71%), and the large-cap index CDSET (-0.70%) closed at 2,017.98, 1,241.53, and 1,061.35 points, respectively. Large-cap sectors posted mixed performance today. NBFI booked the highest gain of 3.45%, followed by Fuel & Power (+0.32%), Telecommunication (+0.18%), Engineering (-0.65%), Food & Allied (-0.91%), Bank (-0.99%), and Pharmaceutical (-1.29%), respectively. Block trades contributed 3.2% of the overall market turnover. eGeneration Limited (+5.1%) was the most traded share with a turnover of BDT 388 million.




