


# **Daily Market Update**

The market closed in red today. The benchmark index DSEX (-0.60%) lost 31.63 points and closed at 5,278.88. The blue-chip index DS30 (-0.73%), the Shariah-based index DSES (-0.66%), and the large-cap index CDSET (+0.03%) closed at 1,886.73, 1,152.55, and 1,011.62 points, respectively. Most of the large-cap sectors posted negative performance today. NBFI experienced the highest loss of 2.03% followed by Telecommunication (-1.46%), Pharmaceutical (-0.43%), Fuel & Power (-0.30%), Engineering (-0.19%), Bank (-0.17%), and Food & Allied (+1.06%), respectively. Block trades contributed 9.4% of the overall market turnover. IFIC Bank Ltd. (+7.6%) was the most traded share with a turnover of BDT 214 million.


