# **Daily Market Update**

The market closed in red today. The benchmark index DSEX (-0.95%) lost 50.49 points and closed at 5,265.85. The blue-chip index DS30 (-0.60%), the Shariah-based index DSES (-1.04%), and the large-cap index CDSET (-0.81%) closed at 1,953.68, 1,175.51, and 1,081.69 points, respectively. All the large-cap sectors posted negative performance today. NBFI experienced the highest loss of 3.31% followed by Engineering (-2.57%), Pharmaceutical (-1.23%), Telecommunication (-1.16%), Bank (-1.04%), Fuel & Power (-0.58%), and Food & Allied (-0.57%), respectively. Block trades contributed 21.2% of the overall market turnover. Bangladesh Shipping Corporation (+6.7%) was the most traded share with a turnover of BDT 217 million.




