## **Daily Market Update**

The market closed in red today. The benchmark index DSEX (-0.80%) lost 39.17 points and closed at 4,860.75. The blue-chip index DS30 (-0.96%), the Shariah-based index DSES (-1.16%), and the large-cap index CDSET (-0.64%) closed at 1,910.31, 1,010.71, and 1,017.68 points, respectively. Most of the large-cap sectors posted negative performance today. NBFI experienced the highest loss of 3.16% followed by Telecommunication (-1.19%), Pharmaceutical (-1.12%), Food & Allied (-0.83%), Bank (-0.71%), Engineering (-0.69%), and Fuel & Power (+1.27%), respectively. Block trades contributed 3.3%

of the overall market turnover. Anwar Galvanizing Ltd. (-6.1%)

was the most traded share with a turnover of BDT 215 million.




