Daily Market Update

The market closed in red today. The benchmark index DSEX (-0.50%) lost 27 points and closed at 5,328.33. The blue-chip index DS30 (-0.48%), the Shariah-based index DSES (-0.55%), and the large-cap index CDSET (-0.62%) closed at 1,976.92, 1,182.95, and 1,090.86 points, respectively. Large-cap sectors posted mixed performance today. Fuel & Power booked the highest gain of 0.95%, followed by Food & Allied (+0.45%), Pharmaceutical (+0.08%), Engineering (-0.84%), Bank 0.93%), NBFI (-1.14%), and Telecommunication (-1.41%), respectively. Block trades contributed 3.2% of the overall market turnover. Far East Knitting & Dyeing Industries Limited (-5.6%) was the most traded share with a turnover of BDT 203 million.




