Daily Market Update

The market closed in red today. The benchmark index DSEX (-1.37%) lost 71.98 points and closed at 5,169.79. The blue-chip index DS30 (-1.64%), the Shariah-based index DSES (-0.97%), and the large-cap index CDSET (-0.90%) closed at 1,892.77, 1,162.65, and 1,070.50 points, respectively. All the large-cap sectors posted negative performance today. NBFI experienced the highest loss of 3.60% followed by Telecommunication (-2.57%), Food & Allied (-2.16%), Engineering (-1.92%), Fuel & Power (-1.36%), Pharmaceutical (-0.87%), and Bank (-0.49%), respectively. Block trades contributed 6.7% of the overall market turnover. Taufika Foods and LOVELLO Ice-cream PLC (+2.5%) was the most traded share with a turnover of BDT 180 million.




