


Daily Market Update

The market closed in red today. The benchmark index DSEX (-0.30%) lost 17.19 points and closed at 5,786.52. The blue-chip index DS30 (-0.05%), the Shariah-based index DSES (+0.08%), and the large-cap index CDSET (-0.16%) closed at 2,133.10, 1,237.48, and 1,143.38 points, respectively. Largecap sectors posted mixed performance today. Engineering booked the highest gain of 1.85%, followed by Pharmaceutical (+0.50%), Telecommunication (+0.37%), NBFI (-0.49%), Bank (-0.60%), Fuel & Power (-0.66%), and Food & Allied (-0.96%), respectively. Block trades contributed 4.0% of the overall market turnover. BRAC Bank Ltd. (-1.4%) was the most traded share with a turnover of BDT 342 million.


