


Daily Market Update

The market closed in red today. The benchmark index DSEX (-0.26%) lost 14.74 points and closed at 5,711.77. The blue-chip index DS30 (-0.72%), the Shariah-based index DSES (+0.08%), and the large-cap index CDSET (-0.62%) closed at 2,085.53, 1,246.68, and 1,128.96 points, respectively. Most of the large-cap sectors posted negative performance today. Food & Allied experienced the highest loss of 1.35% followed by Pharmaceutical (-0.91%), NBFI (-0.82%), Bank (-0.69%), Fuel & Power (-0.18%), Telecommunication (+0.35%), and Engineering (+0.92%), respectively. Block trades contributed 5.6% of the overall market turnover. Linde Bangladesh Limited (+2.5%) was the most traded share with a turnover of BDT 423 million.


