## **Daily Market Update**

The market closed in red today. The benchmark index DSEX (-0.01%) lost 0.3 points and closed at 5,734.97. The blue-chip index DS30 (-0.55%), the Shariah-based index DSES (+0.45%), and the large-cap index CDSET (+0.21%) closed at 2,094.80, 1,263.48, and 1,142.15 points, respectively. Most of the large-cap sectors posted negative performance today. NBFI experienced the highest loss of 1.46% followed by Engineering (-1.24%), Fuel & Power Telecommunication (-1.14%), Pharmaceutical (-1.02%), Food & Allied (-0.93%), and Bank (+1.44%), respectively. Block trades contributed 7.3% of the overall market turnover. Agni Systems Ltd. (+1.5%) was the most traded share with a turnover of BDT 338 million.




