Daily Market Update

The market closed in red today. The benchmark index DSEX (-1.70%) lost 97.37 points and closed at 5,639.13. The blue-chip index DS30 (-1.44%), the Shariah-based index DSES (-2.42%), and the large-cap index CDSET (-1.75%) closed at 2,064.93, 1,261.94, and 1,151.33 points, respectively. All the large-cap sectors posted negative performance today. NBFI experienced the highest loss of 2.91% followed by Engineering (-2.73%), Fuel & Power (-1.24%), Food & Allied (-1.14%), Telecommunication (-0.98%), Pharmaceutical (-0.74%), and Bank (-0.43%), respectively. Block trades contributed 2.9% of the overall market turnover. Social Islami Bank Limited (+5.7%) was the most traded share with a turnover of BDT 404 million.




