Daily Market Update

The market closed in green today. The benchmark index DSEX (+0.34%) gained 18.98 points and closed at 5,658.12. The blue-chip index DS30 (-0.10%), the Shariah-based index DSES (+0.73%), and the large-cap index CDSET (+0.54%) closed at 2,062.93, 1,271.09, and 1,157.59 points, respectively. Most of the large-cap sectors posted negative performance today. NBFI experienced the highest loss of 1.13% followed by Engineering (-0.55%), Pharmaceutical (-0.52%), Telecommunication (-0.36%), Fuel & Power (-0.25%), Food & Allied (+0.13%), and Bank (+0.63%), respectively. Block trades contributed 1.8% of the overall market turnover. Grameenphone Ltd. (0.0%) was the most traded share with a turnover of BDT 328 million.




