Daily Market Update


Market closed in red today. The benchmark index DSEX (-1.07%) lost 52.04 points and closed at 4,810.22 points. Both the blue chip index DS30 (-1.18%) and the Shariah based index DSES (-1.11%) closed in red. All the large cap sectors showed performance today. negative Engineering experienced the highest loss of 2.21% followed by NBFIs (-1.87%), Power (-1.56%), Telecommunication (-0.93%), Food & Allied (-0.72%), Banks (-0.63%), and Pharmaceuticals (-0.54%). Turnover stood at BDT 3.3 billion (USD 39.4 million). National Tubes (-0.3%) was the most traded share with a turnover of BDT 241.3 million.
