


Daily Market Update

The market closed in red today. The benchmark index DSEX (-0.81%) lost 51.34 points and closed at 6,253.49. The blue-chip index DS30 (-0.67%), the Shariah-based index DSES (-0.85%), and the large-cap index CDSET (-0.32%) closed at 2,198.58, 1,358.79, and 1,210.89 points, respectively. All the large-cap sectors posted negative performance today. Pharmaceutical experienced the highest loss of 1.39% followed by Engineering (-0.33%), Fuel & Power (-0.14%), Food & Allied (-0.13%), Bank (-0.01%), NBF1 (-0.01%), and Telecommunication (0.00%), respectively. Block trades contributed 1.1% of the overall market turnover. Genex Infosys Limited (-8.8%) was the most traded share with a turnover of BDT 745 million.

Figure: Sectorial Turnover (BDT)





Figure: Sectorial Mcap Change
